


9. ADDITIONAL POWERS OF THE TRUSTEES:

6. However, the Trustees may delegate such authority and powers to any other Trustees (Managing Trustee) whom appointed committee or other person or body of persons.

7. The Trustees shall be empowered to appoint Committee or Sub - Committees for any specific purpose or purposes and may also constitute a committee consisting of not more than 9 persons, to advise or to manage and administer the institutions of the Trust.

8. The Trustees shall be entitled to receive charities, donations, contributions, aids, grants, gifts and legacies from others and from the Government for the benefit of the Trust and its beneficiaries.

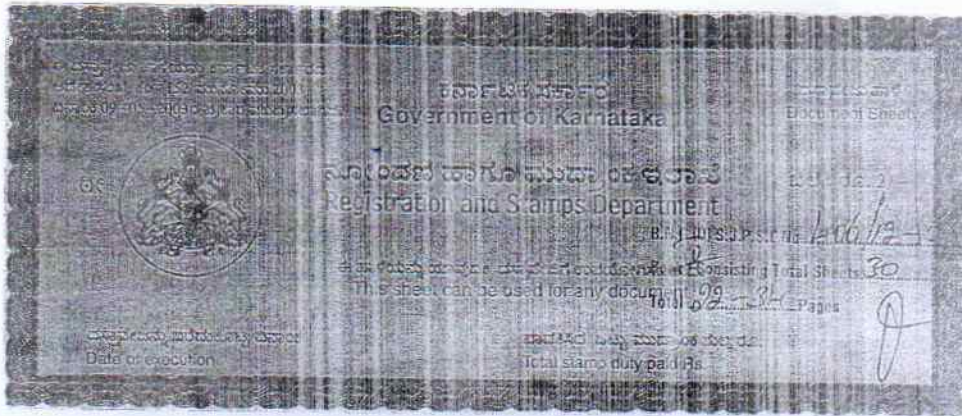



9. The Trustees shall use and apply the funds for the improvements of the Trust and its funds and property/ies for acquisition or property and the up keep of the Trust's property and where there is surplus he shall profitably invest the same for the benefit of the Trust.
10. In the event of any Institution or any society or other agency being amalgamated, liquidated or dissolved the Trustees shall have power to take over, receive, or adopt such institution or society to the folds of the Trust and thereafter manage and administer such society or institution, either as a separate branch or as part of the Trust activities to achieve the objects enumerated supra. The Trustees shall have absolute power to deal with the concerned authorities to complete the formalities in the behalf.
11. The Trustees shall do all necessary acts and deeds aimed at all round development or the benefits of the Trust and shall not do anything which tends to affect the very object of the Trust.
12. The matters not specifically provided for shall be governed by the provisions of the Indian Trust Act.

- e. To permit any agents or any other persons authorized by the TRUST to use and occupy building, erection or other property of the Trust on such terms and conditions as the Trust may deem fit.
- f. To receive and Take, Money or Gift or other property for any of the objects of the Trust and whether subject to any special Trust or not but so that the TRUST may nevertheless decline to accept gift or take over any property having annexed to it any condition or obligation not approved by the TRUST.
- g. To enter into any arrangement with any Government or authority Central, State, municipal or otherwise in pursuance of the objects of the TRUST and to obtain from any such Government or authority all right concessions and privileges which may seem conducive to the TRUST'S object.

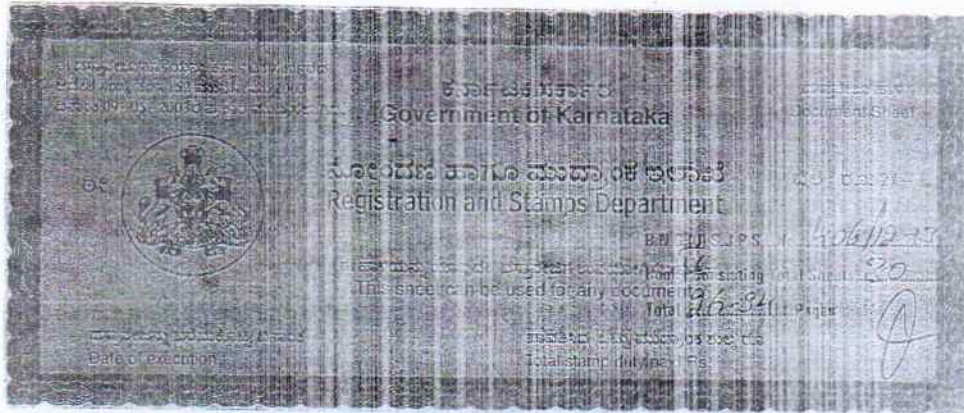

10. DUTIES & RESPONSIBILITIES OF THE CHAIRMAN OF THE TRUST

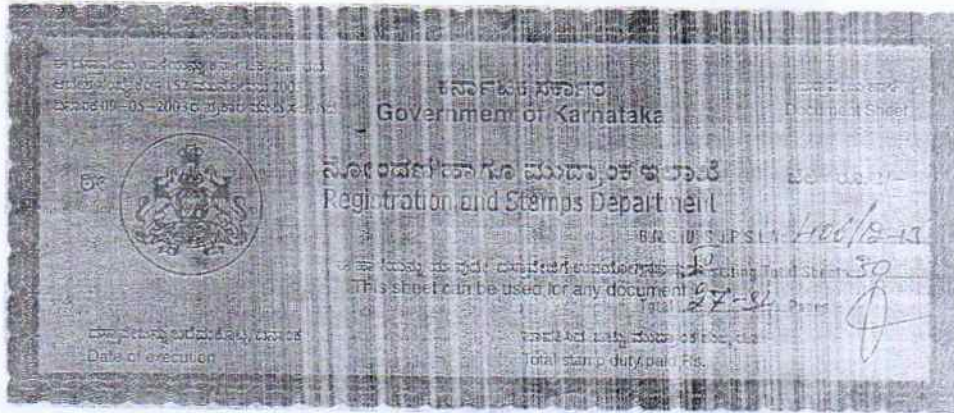

6. The Chairman shall cause the accounts of the Trust placed in the Trust meeting every month, Further, the report of the action taken on the resolutions of the previous meeting of the Board of Trustees shall also be placed in the said meeting and open it for discussions.

2. He shall be responsible for proper maintenance of accounts and books of accounts. He shall get the monthly accounts of the Trust prepared and placed it before the monthly meeting of the Trust. 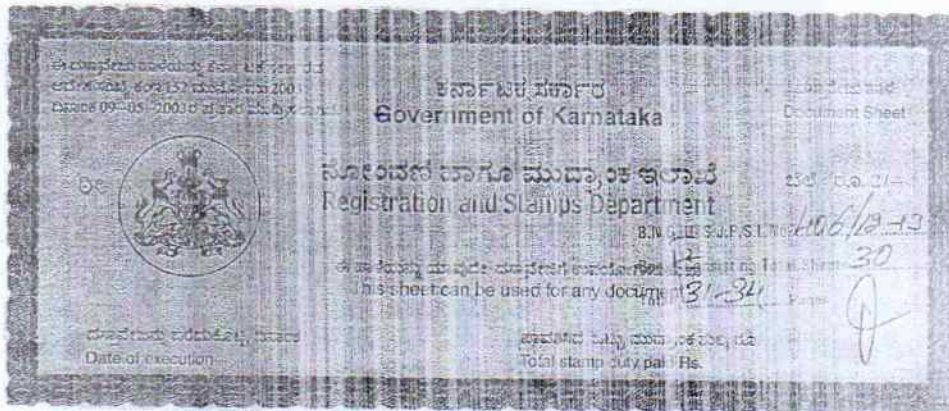

17. BANK ACCOUNTS.

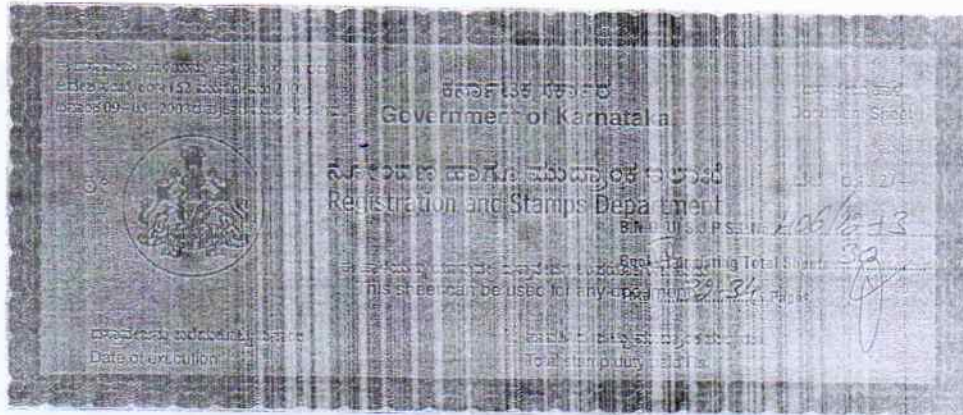





18. VARIATION OF THE TERMS OF TRUST

Further, apart from the points mentioned above, any other resolutions and amendments etc., which is legally, can be made.

19. INDEMNITY








